BISE Activity



It is better to use the strongest requirements so that everyone and especially your employees are protected and you have reduced liability on the work site. He mentioned that there is work being done on an emergency standard for Heat Stress but currently citations use the General Duty Clause. 
We also happenned to have five of our presidents for the Alabama ASSP Chapter in attendance.
